#### **Costs and Forms**

The maximum total cost of the trip per child will be £210.00. This price may well go down if there are more children attending. A £30 non-refundable deposit is now needed to secure your child's place which must be paid by 29<sup>th</sup> November 2024 via ParentPay. Please be aware, if we do not have enough children who are able to attend, we might have to cancel the trip.

## **Pupil Premium**

If your child is in receipt of the Pupil Premium Grant, we will be writing to you separately to inform you of your payment plan but please still complete the form below and hand it in.

#### **Behaviour**

With any trip, it is important that we can trust in your child's behaviour. Therefore, we want to make you aware early on that on <u>very</u> rare occasions it has been necessary to prevent a pupil from participating in a residential activity due to serious concerns regarding:

- Physical aggression towards others
- Repeated unsafe behaviour in school
- Repeated failure to follow adult direction.

Such decisions are not made lightly but children must be trusted to behave safely and responsibly when they are away from home. Any pupil causing us concern will receive three formal warnings so that, wherever possible, the final decision to exclude the pupil from the activity can be avoided. Parents will be informed in the event of a child's first formal warning in writing and asked to meet with the Headteacher and phase leader to discuss their concerns.

In the event of any decision to exclude a pupil, the Headteacher's decision will be final, and monies already paid in these circumstances will be non-refundable for all elements of the trip where the school has been required to pay costs in advance.
